

1 Making a report

- (a) Umpire **Notice of Report** for a report during a match
- (b) Umpire or Club Incident Referral Form (either umpire or club where report has not been made by umpire)
- (c) Executive Officer (CEO / Head of League) Notice of Charge (proceed to step 3)



2 Investigating / considering incident

- After receiving an Incident Referral Form / Notice of Report, the Controlling Body or MRP assesses the alleged reportable offence to determine if a reportable offence occurred.
- This may include:
 - Reviewing match footage
 - Interviewing relevant people (e.g. evidence re. impact) and taking witness statements
- Reportable offence = Notice of Charge (proceed to step 3)



3 Notice of Charge

- As soon as practicable, issue the Notice of Charge to the charged person and that person's club
- Notice of Charge must categorise (and grade) an alleged reportable offence as per Appendix 1 of Policy Handbook
 - Classifiable Offence
 - Direct Tribunal Offence
 - Low-Level Offence

3 Notice of Charge – Grading a Classifiable Offence

- Appendix 1 includes guidance on determining the grading of conduct, impact, contact
- There is provision for reduction in base sanction for an Early Guilty Plea except where 'N/A'

The handbook also:


- Has provision for loading for up to 100% for incidents during a GF
- Provides guidance around various reportable offences (e.g. striking, kicking, contact with umpire etc.) and how to grade conduct, impact and contact.
- There are also vision examples that we can make available upon request for various classifiable offences and how they were graded from AFL and AFLW



4 Tribunal

- Tribunal to consider an offence when:
 - a) player is charged with a direct tribunal offence, or a classifiable offence graded as severe impact
 - b) player declines the EGPO and challenges that they are guilty of any charge
 - c) player declines the EGPO and challenges the charge they were reported for
 - d) player declines the EGPO and elects to plead guilty to an alternative grading of the offence
 - If successful with (c or d), player is eligible for EGP sanction
- Tribunal sanctions:
 - Direct tribunal offence determine sanction in its absolute discretion
 - Classifiable offence sanction in accordance with the classification table
 - Low level offence sanction in accordance with the low-level offence base sanctions

- Offences that must be referred directly to Tribunal:
- VIC Country Handbook as listed under 11.3
- National Policy Handbook direct tribunal offences / classifiable where impact is severe

11.3. Any player reported for the following offences shall appear before the League Tribunal:

22.2.2 (Laws of Australian Football): (a) intentionally or carelessly (ii) kicking another person (iii) kneeing another person (vi) bumping or making forceful contact to an opponent from front-on when that player has their head down over the ball (vii) head butting or making contact to an opponent using the head (b) eye-gouging another person (c) stomping on another person (d) intentionally making contact with or striking an umpire (e) attempting to strike an umpire (f) spitting at or on an umpire (g) behaving in an abusive, insulting, threatening or obscene manner towards or in relation to an umpire (I) spitting at or on another person (cc) engaging in any other act of misconduct or serious misconduct



- Where a set penalty or EGPO and / or reprimand may apply:
- VIC Country Handbook
 - set penalties offered for offences listed under 11.1
 - o umpire can offer set penalty or refer to tribunal
 - \circ tribunal can offer reprimand for certain offences
- National Policy Handbook
 - Classifiable offences must be graded accordingly incl.
 EGPO where reprimand applies
 - Low level offences = EGPO for 1st and 2nd offence is a reprimand (unless CB refer to tribunal)

11.1. Any player reported for the following offences (as numbered in the Laws of Australian Football) may apply for a set penalty suspension of the relevant number of matches as identified. 22.2.2 (Laws of Australian Rules Football): (a) intentionally or carelessly (i) intentionally striking another person (2 match set penalty) carelessly striking another person (1 match set penalty) (iv) charging an opponent (2 match set penalty) (v) engaging in rough conduct against an opponent (2 match set penalty) (ix) making unreasonable or unnecessary contact to the face of another person (1 match set penalty) (x) scratching another person (1 match set penalty) (xi) tripping another person whether by hand, arm, foot or leg (1 match set penalty) (h) using abusive, insulting, threatening or obscene language towards or in relation to an umpire (2 match set penalty (j) carelessly making contact with an umpire (2 match set penalty) (k) disputing a decision of an umpire (1 match set penalty) (m) attempting to strike another person (1 match set penalty) (n) attempting to kick another person (2 match set penalty) (o) attempting to trip another person whether by hand, arm, foot or leg (1 match set penalty) (p) making unreasonable or unnecessary contact with an injured player (2 match set penalty) (q) engaging in a melee, (1 match set penalty) (r) instigating a melee (2 match set penalty) (s) wrestling another person (1 match set penalty) (t) pinching another person (1 match set penalty (u) engaging in an act of staging (1 match set penalty) (v) using abusive, insulting, threatening or obscene language (1 match set penalty) (w) use of an obscene gesture (1 match set penalty) (x) engaging in time wasting (1 match set penalty) (y) interfering with a player kicking for goal (1 match set penalty) (z) intentionally shaking, climbing or otherwise interfering with a goal or behind post (1 match set penalty) (aa) Failing to leave the playing surface when directed to do so by an umpire (2 match set penalty) (bb) wearing boots, jewellery and equipment prohibited under Law 9 of the AFL Laws of Australian Football (1 match set penalty)

Players are encouraged to apply for the minimum set penalty.



- Discretion on matters referred to tribunal
- Sanctions once a matter is referred to the Tribunal
- VIC Country Handbook
 - \circ Absolute discretion
- National Policy Handbook
 - Direct Tribunal Offence absolute discretion (although guidance provided for classifiable offences where impact is severe)
 - Classifiable Offence sanction in accordance with classification table
 - Low Level Offence sanction in accordance with low-level offence base sanctions
